

T&Cs

- Trade waste is only accepted at the listed recycling centres. Any trader using any other recycling centre will be asked to visit one of the designated sites. Any refusal to comply will be recorded and you may be investigated by Norfolk County Council and the Environment Agency
- You'll need to provide your Waste Carriers Licence number. Register online at www.gov.uk/waste-carrier-or-broker or call **03708 506506**
- Once you have paid and disposed of your waste, you will be given a waste transfer note to prove you have transferred your waste to an authorised site
- Vehicle size is limited to 3.5 tonnes maximum
- Arrive on site at least 30 minutes before closing time to allow enough time to dispose of your waste
- The service will be subject to operational capacity and priority will be given to householders
- Traders are expected to place their own waste in the correct containers, so bring help if you need it
- Mixed loads will be charged at the non-recyclable rate
- We only accept plasterboard if you separate it from the rest of your waste



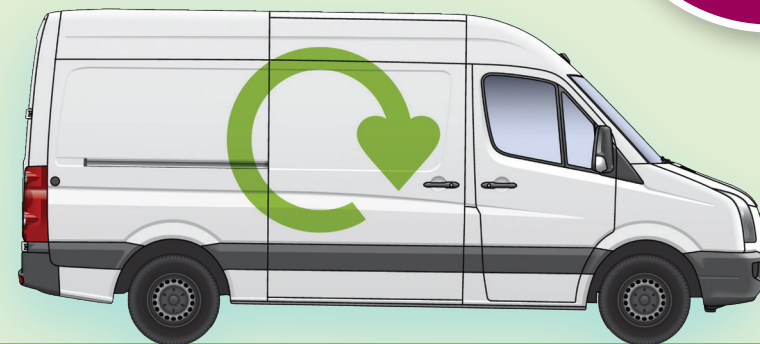

What types of trade waste do we accept?

- Unsorted/non-recyclable waste
- Green waste
- Flat glass
- Rubble
- Plasterboard
- Timber
- Scrap metal
- Paper, textiles, card, and glass bottles

We don't accept electricals or hazardous waste or any materials not usually accepted from householders.

How much waste can I bring?

This service is only available to small traders. Vehicles over 3.5 tonnes are prohibited.

How much will it cost?

- Prices are calculated according to the volume and type of waste you bring. You'll pay less if you separate your waste - separated recyclable materials are charged at a lower rate than mixed loads
- Plasterboard needs to be separated or it cannot be accepted
- Please see a member of staff before unloading. Your load will be assessed and a price given. Prices are non-negotiable and a minimum charge will apply. Prices cannot be given in advance of your visit. **The decision of staff is final**

You can pay by credit or debit card, but not cash. No refunds will be given once payment has been taken and the waste disposed of.
