

Single-Use Summer Swap Competition – Terms and Conditions

The competition is open to all Norfolk residents, except for anyone directly connected with organising the competition.

The competition is being run by, and the prize provided by, Norfolk Recycles.

There is no fee to enter this competition.

By entering this competition, an entrant is indicating his/her agreement to be bound by these terms and conditions.

Closing date for entry will be Monday 6th September 2021 at 11.59pm. After this date, no further entries to the competition will be accepted.

No responsibility can be accepted for entries not received for whatever reason.

Only one entry per person will be entered into the prize draw.

By entering the competition, entrants (or their parents/guardians if entrant is under 18) are agreeing to their picture/photo, first name and age (if entry is from a child) being featured on norfolkrecycles.com and related social media accounts.

The rules and how to enter are as follows:

To enter the prize draw you must complete the following by the closing date:

- The entrant should either take a photo or draw a picture to show how they've swapped a single-use item for a reusable one, or draw a picture to show a swap they intend to make
- If submitting a drawing (rather than a photograph), it can be any size and completed using any medium the entrant chooses
- Once the entry is complete, the photograph or scanned/photographed image of the drawing should be emailed to zerowaste@norfolk.gov.uk
Please include the entrant's first name and age (if entrant is a child)
- All entrants must live in Norfolk to be eligible to be entered into the prize draw

A selection of entries may be featured on Norfolk Recycles, Norfolk County Council and other appropriate linked social media platforms. Having your entry featured on social media does not mean you are a prize winner.

The prize is

- 1 x Chilly's 'Refill' water bottle
- 1 x bamboo lunchbox

The prizes are as stated (and as pictured on the activity sheet), and no cash or other alternatives will be offered. The prize is not transferable.

Selecting the prize winner

- After the closing date, one winner will be selected at random from all entries received that fully meet the outlined entry requirements
- The winner will be notified via email within one month after the closing date

If a winner cannot be contacted, has not met all criteria for entry or does not claim the prize within 14 days of notification, we reserve the right to withdraw the prize from the winner and pick a replacement winner.

Delivery of the prizes will be made to a domestic address in mainland UK only.

The promoter's (Norfolk Recycles) decision in respect of all matters to do with the competition will be final and no correspondence will be entered.
